| At the above date and time, I Officer Hall was dispatched to the Franklin Police Department for a lobby report. I met with the R/P Natalya Shub. Natalya advised at 10:27 PM on 08/29/2022, that one of her political signs was taken from her front yard. Natalya stated that she had four signs in her front yard and her David Goldberg sign had been taken by an unknown subject. Natalya showed me the Ring Doorbell video. The video showed the unknown suspect taking the sign from her yard. I requested she send the video to my email so I could add it to the report. I then |



provided Natalya the CFS number for the report.

I was later contacted by Natalya and advised that the unknown subject was David Sahli. Natalya stated that David called Natalya to apologize. Natalya stated that he removed the sign due to the city ordinance that only allows up to three signs in a yard. Natalya advised that she did not wish to press charges.
